Entertainment and Sport

We also provide multidisciplinary legal advice to the audio-visual sector (national and foreign production companies, festivals and other agents in the sector) at all stages of production, as well as to the music and live performance sector, providing support to artists, agents, promoters, record labels, ticketing companies, etc.

In sport, we work with federations, clubs, SAD and sportsmen and women, offering solutions in contracting, legal representation and disciplinary or judicial procedures. Our experience ranges from tax planning to strategic advice on rights and licensing, guaranteeing efficiency and protection with the aim of enhancing the success of our clients.

03.1 Audiovisual industry



Ongoing legal advice

Drafting and monitoring the negotiation of contracts for the assignment of exploitation rights, starter agreements, national/international co-production contracts and production service agreements (PSA), among others.

Review of the chain of title and underlying rights.

Analysis and resolution of queries in relation to applications for national and international production funding. Advice on the initial structuring of the project in order to maximise the compatibility of direct funding (subsidies) and indirect funding (tax credit).

Analysis of requirements for obtaining citizenship. In relation to international coproductions, review of applicable bilateral and multilateral treaties.

Advising on the acquisition of commitments affecting the financing and operating plan of projects, such as capitalisations or inter-party agreements for the distribution of profits.

Project-based consultancy

Review of contracts for the advance acquisition of exploitation rights with broadcasting companies - according to market -, distributors, international sales agents and platforms.

Review of contracts with the project's authoring team (script, direction, direction of photography and composition of original music), as well as executive production contracts and other contracts related to the execution of the audiovisual production.

Legal analysis of the script and drafting of the clearance report.

Agreements/authorisations for brand placement in the project.

Contractual model in accordance with the terms set out in the collective agreements applicable to the hiring of technical and artistic personnel.

Advice on the processing of visas and work permits.

Advice on the recognition of the cost of public funding.

Deduction for investment/Media production management


Control of the tax benefits generated, including their correct determination and quantification.

Review of compliance with the requirements necessary for the correct transfer of the tax rebate.

Active search seeking investors interested in tax credits for investments in audiovisual productions.

Advice on how to obtain the tax rebate for the execution of foreign audiovisual productions (tax rebate).

Formalisation of contracts governing the relationship with investors - framework agreement - through EIGs or financing contracts.



03.2 Music industry



Music creation and production

Specialised legal advice on intellectual property matters: mapping of rights, analysis of ownership chains, drafting and negotiation of contracts (recording, distribution, publishing, commissioning of works, licences for synchronisation and transformation of works, theatrical performance and musical performance, among others).

Tax planning service for artists.

Internal organisational framework for music ensembles: band contracts and partnership agreements.

Advice on the negotiation of artistic and executive production contracts.

Legal support in dealings with institutions in the field of intellectual property (registrations, licences or settlements with collective management entities) and industrial property (registration and defence of trademarks at national or international level).

Drafting of a legal framework in order to generate NFT licences.

Live performances

Drafting and negotiation of live performance contracts, contracts with venues and concert locations, co-production contracts for events. Development of the contractual framework for the exploitation of live streaming and fake live streaming of artistic performances.

Negotiation of advertising contracts (sponsorship contracts, naming rights contracts and advertising broadcasting contracts, among others).

Structuring of tax incentives and attracting investment for projects. Specialised advice on international taxation and tax implications of performances by foreign artists in Spain. Legal support in the processing of subsidies.

Specialised legal advice in the field of ticketing, RFID/NFC cashless payment systems and cryptocurrency payment services at concerts and festivals.

Management and representation

Drafting and negotiation of management, booking and 360° management contracts.

Creation of a contractual framework governing the orderly termination of the managerartist relationship (residual income time horizon and sunset clauses, among others).

Legal advice in those areas of the artist's activity managed directly by the agency (agreements with brands and sponsorship or endorsement contracts, among others).

Control of the tax benefits generated by the live show produced and their proper determination and quantification.

Review of the necessary requirements for the correct transfer of the tax deduction.

Active search and recruitment of investors interested in acquiring these tax deductions (tax credit).

Formalization of the documents that regulate the relationship with investors: financing contract or entry into an AIE.



03.3 Sport
