Our experience encompasses the conduct of complex and/or economically significant court and arbitration proceedings, including legal defence before international arbitration tribunals. We are also able to address the need of some clients to manage and handle a large volume of cases with the support of procedural managers who ensure their rapid progress.

Pre-litigation advice and legal direction in all types of legal proceedings and arbitration in civil and commercial matters.

- Analysis of conflicts, prior to the commencement of legal or arbitration proceedings, informing on the rights and actions of the defendant, encouraging either negotiation to reach an amicable solution, making use of mediation if so desired or previously agreed by the parties, or preparing the best possible strategy by issuing summonses, sending communications, preparing evidence such as notarial deeds, technical reports, etc.
- Legal management of national and international arbitrations, both ad hoc and institutional or presided over by the main arbitration courts.
- Creation of multidisciplinary teams, when the size and/or complexity of the matter so requires, in which the litigation specialists are assisted by experts in the matters in dispute (corporate, financial, real estate, inheritance, etc.).
- Legal intervention in all types of individual and collective actions, in all types of voluntary jurisdiction proceedings and judicial proceedings (declaratory, special and executive), incidents and appeals (including extraordinary procedural infringement and cassation proceedings before the Supreme Court, appeals for protection before the Constitutional Court and appeals before the Court of Justice of the European Union), on the most diverse matters (filiation, separations and divorces, rights to reputation, personal privacy and personal image, breach of contracts of all kinds, evictions, construction defects, challenges to corporate agreements, health extracontractual liability, defective products, traffic accidents, etc.)

- Legal representation in judicial proceedings in the contentious-administrative jurisdiction, both in defense of private clients and public sector entities.
- Defense in criminal proceedings of both individuals and legal entities, including the Public Administration and banking entities.
