Public and Regulatory

Our advice ranges from the issuing of legal opinions to the handling of all types of administrative proceedings and appeals, reaching all levels and in all matters, including constitutional jurisdiction, in the contentious-administrative jurisdiction. We also advise public administrations and other public sector entities. All this allows us to address any legal-public issue with a practical and comprehensive approach.

## Regulated sectors

#### **Tourism**

## Energy

Assistance on all matters relating to town planning, the environment, applications for declarations of public utility, compulsory expropriation, public domain (water, maritimeterrestrial, mountains, roads, livestock trails, roads, etc.) and any other.

## Energy

## Town and country planning

Drafting of the report on reparcelling projects and overseeing the process until they are registered in the land registry.

Intervention in procedures for obtaining land for general/local systems by direct occupation or expropriation.

Advising on expropriation and property liability proceedings as a result of town planning or land use planning.

Reports and opinions on urban planning or sectorial regulations; due diligence or urban planning audits.

## Town and country planning

Advice on the procedure for the granting of all types of urban planning licences (commercial licences, works, installation, first occupation, opening, demolition, activity, etc.) and the necessary sectorial authorisations.

Legal advice on the processing of special authorisations on rural land, by obtaining authorisation prior to licensing.

Legal advice on the regularisation of buildings by declaring them to be in a situation of assimilated out of ordination -SAFO-, and in procedures for the regime of licensed buildings -RAEL-.

Defence in disciplinary proceedings and proceedings for the restoration of legality.

Advice on subsidised housing.

Preventive advice on offences against town and country planning.

Administrative and contentious-administrative appeals in urban or sectorial matters.

# Sustainability and Environment

Special appeals in procurement matters before the contract review tribunals; ordinary administrative appeals before the various contracting authorities; and improper appeals before the bodies of other public sector entities.
